The Manager provides advice and support to the Executive Director regarding advocacy policy and procedures, quality assurance, systemic issues, and complex or urgent cases. The Manager may also be responsible for office staff and operations. The Manager contributes to the development of a province-wide network to promote self-advocacy, advocacy and community capacity development. The Manager manages a small advocacy caseload and conducts special projects as assigned.
